Discrimination in prison

It's against the law for the prison to treat you less fairly because of:

- disability
- gender reassignment
- pregnancy and maternity
- race
- religion or belief
- sex
- sexual orientation.

If you are not treated equally or fairly because of any of these things, this is called discrimination.

There is also a written Prison Service policy which say that all prisoners and their visitors should be treated with respect.

Everyone in prison should have equal access to facilities, including jobs, education, library services, exercise and accommodation.

There may be times when a prisoner or a visitor feels they are being discriminated against. Examples include:

- prison staff show they are prejudiced against some prisoners, like black people or Gypsies, either by what they do or what they say. It's against the law for staff and other prisoners to use racist language and they can be disciplined for this
- you are disabled and you are not provided with a suitable wheelchair which means you can't take part in many activities. This is against the law
- you feel you are being victimised because you support another prisoner with his complaint about racial harassment. This is against the law
- you're on a disciplinary hearing. You can't understand English and the prison won't provide you with an interpreter

What can you do if you're treated unfairly because of your race or religion

If you think that you, or other prisoners, are being treated unfairly, you could discuss the problem with the Race Relations Liaison Officer. Fill in a Racist Incident Reporting Form which is available on all wings. Put it in a complaints box. The Race Relations Liaison Officer will come and talk to you about the complaint. If you are not happy with the result, a full investigation will be carried out.

What can you do if you're treated unfairly because of your disability

If you think that you, or other prisoners, are being treated unfairly, you could discuss the problem with the Disability Liaison Officer or fill in a complaint form.

What can you do if you're being treated unfairly for other reasons

If you think that you, or other prisoners, are being treated unfairly for other reasons, you will have to make a complaint in the normal way - (see under heading Further Help)

Court action

If you are being treated unfairly, you could think about taking court action against the prison. You might get compensation. You need to speak to a specialist adviser about how to do this. For example, the Prisoners' Advisory Service has a specialist Race Discrimination Caseworker who can help you take court action in a race discrimination case. Legal aid might be available.

Citizens Advice Bureaux give free, confidential, impartial and independent advice to help you solve any sort of problem.

Some Citizens Advice Bureaux run advice sessions in prison. If you're in prison, check if they run these sessions in your prison. If they don't run advice

sessions, you could write to them explaining your problem. Ask a member of the prison staff for the address of your local CAB.
